Background Information

Lawrence Virtual School's Kdg-8th grade curriculum is provided by K12 INC. USD 497 entered a 5 year curriculum agreement with K12 on March 13, 2006. Payments are made to K12 on a monthly basis. If a student withdraws from LVS, then payment for that student ceases.

Rationale

The district has sponsored the Lawrence Virtual School over the past three years. We continue to see gains in enrollment. The rigor and quality curriculum K12 provides is one aspect of continued interest in LVS. The average cost of curriculum access, resources and materials is \$2150.00 per pupil annually.

Recommendation

The administration recommends that the Lawrence School District purchase curriculum for up to 780 students at LVS for the 2007-08 school year.
