Special Recognition

The Lawrence Board of Education on Monday recognized Quail Run Elementary as part of the district's showcase of schools. Principal James Polk shared a video highlighting how students and staff build community. He mentioned several activities supporting strong connections, including monthly assemblies educating students about important topics, such as Native American and Hispanic Heritage Months. Quail Run is a Special Olympics Unified Champion School for its dedication to inclusion. Teachers meet with multiage groups of students, called Coveys, once a month to build relationships and focus on social emotional learning and character development. The focus this month is on showing gratitude.

Sunset Hill Elementary Principal Jeremy Philipp honored Stephanie Dickson, the Kansas Association for Health, Physical Education, Recreation, & Dance Elementary 2023 P.E. Teacher of the Year. Philipp described Dickson as "amazing" and said, "She is energetic and gifted at creating engaging lessons." Dickson also serves as the district's lead elementary P.E. teacher, supporting colleagues and mentoring new physical education teachers. In addition, she coaches girls basketball at West Middle School.

"I am only as awesome as the school that I am at, working with the staff and students I love," said Dickson. "I am thankful to be a part of USD 497."
