SPECIAL RECOGNITION

Lawrence High School Student Engineering Design Contest Champions

Charlie Lauts, career & technical education teacher, recognized the team of Lucas Mackey, Chris Smith and Sean McClaskey that won First Place Overall at the KU School of Engineering "To the Moon and Back" competition held on November 5, 2014. Ms. Lauts reported that 51 Lawrence High students participated in the competition that included over 100 teams from 25 high schools.

Special Recognition ~ LHS Student Engineering Design Contest Champions (Continued)

Teams of four or less students designed and built a rover and launcher that had to land on the moon as close as possible to a designated target. The rover then had to be maneuvered down hilly moon terrain to a base with the goal of driving as straight and as far as possible. The teams then made a presentation to the judges about their design process. The most accurate launch and the longest distance traveled secured the win for the Lawrence High team.

<u>Lawrence High School Interpersonal Skills Program Unified Sports Basketball Team</u> Medalists

Senior Nyle Anderson introduced members of two Lawrence High Unified Sports basketball teams that placed first (IPS Ballers) and second (Dream Chasers) in different divisions at a tournament held in Atchison on Sunday, November 9. He reported that Unified Sports is an all-inclusive sports program that is supported by Special Olympics and sponsored at the school by the Interpersonal Skills Program. Teams are made up of at least three "athletes" (qualifiers for Special Olympics) and two "partners."

Members of the teams include John Barbee, Emma Bentzinger, Ayesha Dunlap, Shyanne Garcia, Kenzie Garvin, Amy Gonce, Adam Graham, Cheyenne Graham, Anthony Harvey (coach), Chase Odgers, Alex Pickerel, Kendall Pritchard, Justin Roberts (coach), Kyleigh Severa, George Wedge and Luke Zenger.

It was noted that this is the first year for the program at Lawrence High School. The teams practiced once a week and competed in two tournaments, plus they recently participated in "Pack the House" at the school. Teacher sponsors are Susie Micka and Drew McDaniel.

REPORT OF BOARD PRESIDENT SHANNON KIMBALL

Board President Shannon Kimball reported that she attended yesterday the Delegate Assembly of the Kansas Association of School Boards Annual Convention in Topeka as the voting representative for the USD 497 Board of Education. She reported that the assembly adopted the Legislative Committee recommendations as presented, except for some small grammatical edits. Ms. Kimball said that prior to the meeting, she had spoken with a board member from Shawnee Mission, who also served on the Legislative Committee, who voiced interest in amending the Legislative agenda to include STEAM goals in terms of student achievement. Ms. Kimball reported that she also spoke to the delegate assembly in favor of the amendment. The Legislative Committee had discussed this prior to the meeting and plan to include it next year on the agenda.

REPORT OF SUPERINTENDENT RICK DOLL

 Superintendent Rick Doll stated that it was his pleasure today to recognize Darin Fischer, art teacher at Prairie Park Elementary School, with this year's Lawrence Master Teacher Award. He noted that Darin has been teaching in Lawrence Public Schools for 25 years. Dr. Doll stated that, in addition to being an outstanding studentfocused educator, Darin mentors new art teachers in the district, works with student teachers, helps develop curriculum and align it with standards, and serves as a leader on his school's Equity Team.

Report of Superintendent Doll (Continued)

- Superintendent Doll extended congratulations to Lawrence High junior Stefan Petrovic, who earned the highest score in the state on the Youth Senate exam and has been selected to represent Kansas as a delegate to the 2015 Youth Senate Program. In addition to this honor, Stefan will receive a \$5,000 scholarship and a trip to Washington, DC.
- He announced that a Free State High School visual art and poetry project will be part
 of a community display this week in the main gallery of the Lawrence Public Library.

BOARD COMMENTARY

Rick Ingram

...reported that he, along with Kris Adair and Bob Byers, toured the Cordley Elementary School building earlier in the day. He stated that it is going to be a very modern building with character. Mr. Ingram also stated that all six buildings being renovated are going to be very nice, and he expressed appreciation to all who have been involved in the planning and process, saying he believes students and parents will be very impressed with the results.

OLD BUSINESS

Approval of Bid & Resolution for General Obligation Bonds

Kyle Hayden, assistant superintendent, business & operations, and Kathy Johnson, director, finance, shared information in regard to the bid results for the sale of \$36,000,000 of General Obligation Bonds. It was reported that out of seven close bids, Wells Fargo Bank, National Association had the winning bid. It was also reported that a resolution relating to the bonds will also need to be approved.

Following a motion by Randy Masten, seconded by Vanessa Sanburn, the board voted, in a 7-0 roll call vote, to accept the winning bid at 3.18001 net interest rate (TIC) from Wells Fargo Bank, National Association—New York, NY for the district's General Obligation Bonds, Series 2014-A.

Following a motion by Shannon Kimball, seconded by Bob Byers, the board voted, in a 7-0 roll call vote, to adopt a resolution authorizing and directing the issuance, sale and delivery of General Obligation Bonds, Series 2014-A of Unified School District No. 497, Douglas County, Kansas (Lawrence); providing for the levy and collection of an annual tax for the purpose of paying the principal of and interest on said bonds as they become due; making certain covenants and agreements to provide for the payment and security thereof; and authorizing certain other documents and actions connected therewith." Approval of Bond Construction Bids - Sunset Hill Elementary School

Kyle Hayden, assistant superintendent, business & operations, along with Dean Youngers, construction manager, bond projects, reported that McCownGordon Construction partnered with Gould Evans Architects and Smith & Boucher Engineers on bond construction package 1 which includes Sunset Hill Elementary School. Bids were received on November 11, 2014, and the Guaranteed Maximum Price (GMP) is \$8,329,566, which includes a technology package totaling \$149,564.

Design plans and renderings for the Sunset Hill site were presented. It was noted that construction will take place in three phases beginning in March, 2015 with areas for parking. Phase Two will occur from June 1 through December 21 and will include work

Old Business ~ Approval of Sunset Hill Elementary Bond Construction Bids (Continued) across the entire site. During that time, students will attend classes at East Heights. Staff and students will return to the building in January, 2016 during Phase Three of the construction which will happen on a portion of the site.

Following a motion by Vanessa Sanburn, seconded by Shannon Kimball, the board voted, in a 7-0 roll call vote, to approve the Guaranteed Maximum Price contract amendment with McCownGordon (Construction) in the amount of \$8,329,566 for bond construction at Sunset Hill Elementary School.

Boundary Advisory Committee Report & Recommendations

Kyle Hayden, assistant superintendent, business & operations, stated that during the Board of Education meeting on November 24, 2014, where a report and boundary recommendations were presented, the Boundary Advisory Committee (BAC) was given further direction to explore other options specifically related to the movement of Deerfield, Quail Run and Schwegler students.

Mr. Hayden reported that the BAC met on December 3, 2014, and community presentations were held at Deerfield and Schwegler on December 4. He revealed information that came from those meetings including boundary committee recommendations, which were unchanged, and alternate administrative options for Deerfield to Sunset Hill and Schwegler to Hillcrest. Following the presentation, Board President Shannon Kimball acknowledged those who wished to speak in regard to boundary committee recommendations.

Date: January 8, 2015

Background:

GAAF – Emergency Safety Interventions. The board adopted this policy on October 28, 2013 to comply with the new State Board of Education adopted regulations requiring districts to adopt a policy concerning emergency safety interventions applicable to all district students. Administration has developed all of the requisite reporting forms and procedures and staff are being trained in accordance with the regulations.

Since adopting this policy, the Kansas Department of Education has reviewed the policy and requested a correction; therefore, the attached revised policy is presented for the board's consideration.

Recommendation:

The Board Policy Committee recommends the review of the referenced policy. Once the review is complete and any suggested changes are considered, the committee will submit the final recommendations for adoption and/or amendment at the January 26, 2015 board meeting.

Motion:

"I move the Board of Education approve the review of the referenced policies for possible adoption and amendment at its January 26, 2015 meeting."

- The board of education is committed to limiting the use of Emergency Safety Interventions ("ESI"), such as seclusion and restraint, with all students. Seclusion and restraint shall be used only when a student's conduct necessitates the use of an emergency safety intervention as defined below. The board of education encourages all employees to utilize other behavioral management tools, including prevention techniques, de-escalation techniques, and positive behavioral intervention strategies.
- This policy shall be made available on the district website with links to the policy available on any individual school pages. In addition, this policy shall be included in at least one of the following: each school's code of conduct, school safety plan, or student handbook.

11 <u>Definitions</u> (See K.A.R. 91-42-1)

- "Emergency Safety Intervention" is the use of seclusion or physical restraint when a student presents an immediate danger to self or others. Violent action that is destructive of property may necessitate the use of an emergency safety intervention.
- "Seclusion" requires all three of the following conditions to be met: (1) the student is placed in an enclosed area by school personnel; (2) the student is purposefully isolated from adults and peers; and (3) the student is prevented from leaving, or reasonably believes that the student will be prevented from leaving, the enclosed area.
- "Chemical Restraint" means the use of medication to control a student's violentphysical behavior or restrict a student's freedom of movement.
- "Mechanical Restraint" means any device or object used to limit a student's movement.
- 23 "Physical Restraint" means bodily force used to substantially limit a student's movement.

All staff members shall be trained regarding the use of positive behavioral intervention strategies, de-escalation techniques, and prevention techniques. Such training shall be consistent with nationally recognized training programs on the use of emergency safety interventions. The intensity of the training provided will depend upon the employee's position. Administrators, licensed staff members, and other staff deemed most likely to need to restrain a student will be provided more intense training than elassified staff who do not work directly with students in the classroom. District and building administration shall make the determination of the intensity of training required by each position.

Each school building shall maintain documentation regarding the training that was provided and a list of participants.

Notification and Documentation

The principal or designee shall provide written notification to the student's parents any time that ESI is used with a student. Such notification must be provided within two (2) school days.

In addition, each building shall maintain documentation any time ESI is used with a student. Such documentation must include all of the following:

- Date and time of the intervention,
- Type of intervention,
 - Length of time the intervention was used, and
- School personnel who participated in or supervised the intervention.

All such documentation shall be provided to the building principal, who shall be responsible for providing copies of such documentation to the superintendent on at least a biannual basis. At least once per school year, each building principal or designee

shall review the documentation of ESI incidents with appropriate staff members to consider the appropriateness of the use of ESI in those instances.

Reporting Data

District administration shall report ESI data to the state department of education as required.

Local Dispute Resolution Process

The board of education encourages parents to attempt to resolve issues relating to the use of ESI informally with the building principal and/or the superintendent before filing a formal complaint with the board. In the event that the complaint is resolved informally, the administrator must provide a written report of the informal resolution to the superintendent and the parents and retain a copy of the report at the school. The superintendent will share the informal resolution with the board of education and provide a copy to the state department of education.

If the issues are not resolved informally with the building principal and/or the superintendent, the parents may submit a formal written complaint to the board of education by providing a copy of the complaint to the clerk of the board and the superintendent.

Upon receipt of a formal written complaint, the board president shall assign an investigator to review the complaint and report findings to the board as a whole. Such investigator may be a board member, a school administrator selected by the board, or a board attorney. Such investigator shall be informed of the obligation to maintain confidentiality of student records and shall report the findings and recommended action to the board in executive session.

Any such investigation must be completed within thirty (30) days of receipt of the formal written complaint by the board clerk and superintendent. On or before the

30th day after receipt of the written complaint, the board shall adopt a report containing 1

Re: Addendum to Track & Tennis Court Projects – Liberty Memorial Central

Date: January 8, 2015

Background:

The Board of Education was presented with and approved the Capital Improvement Project list at its January 13, 2014 meeting. The plan included several site and athletic facility improvements including the construction of a new 200 meter track at Liberty Memorial Central Middle School. At that time, it was noted that a number of ADA site accessibility issues would be addressed during the project.

Bids and Specifications:

Landplan Engineering was hired for the development of project specifications and design and construction administrative services.

McConnell & Associates is providing the products, services, and construction administration services for the above referenced projects through the TIPS/TAPS Cooperative Purchasing contract.

The original project approval for the middle school track improvements was done on April 14, 2014 for \$430,000 with an ADA addendum for LMCMS of \$31,944 approved on June 30, 2014 (\$461,944 Total).

In order to meet and exceed ADA site accessibility requirements and provide additional onsite security at Liberty Memorial Central Middle School, the following additions are recommended:

- Install additional 4 ft. galvanized fence between the walkway from the tennis courts to the fence along the north side of the tennis courts.
- Modify the northwest and the southeast gates for the tennis courts in order the make them 5 ft. wide.
- Install fence/handrail along the ADA ramp from the tennis courts to the bleacher pad at the football field.

Cost for additions: \$4,664

Recommendation:

Administration recommends board approval of the additional costs of \$4,664 for the installation of the 4 ft. galvanized fencing, tennis court gate modification, and ADA ramp handrail at the Liberty Memorial Central Middle School track and tennis courts. This addition brings the middle school track projects to a total cost of \$466,608 with McConnell and Associates.

Background:

The University of Kansas (KU) Department of Special Education and Unified School District No. 497, Douglas County, Kansas, Lawrence Public Schools (LPS), are entering into an agreement to enable KU's Department of Special Education to provide consulting services and facilitate the CI3T (Comprehensive, Integrated, Three-tiered Model of Prevention) processes for the district's secondary buildings. This will support BOE Goal 2.1.5 - Implement Positive Behavioral Interventions & Supports (PBIS) with Comprehensive, Integrated, Three-tiered Model of Prevention (MTSS:CI3T) as a model.

University of Kansas Center for Research, Inc., on behalf of the University of Kansas' Department of Special Education (hereinafter "KUCR"), and UNIFIED SCHOOL DISTRICT NO. 497, DOUGLAS COUNTY, KANSAS, Lawrence Public Schools (LPS), desire to enter into this agreement to enable the University of Kansas, Department of Special Education to provide research services and facilitate CI3T (Comprehensive, Integrated, Three-tiered Model of Prevention) processes at the secondary level. To facilitate this purpose, the parties agree as follows:

1. The KUCR agrees to:

- a. Provide research qualified personnel to perform the required services as described in Attachment A, Scope of Work. Such personnel shall at all times be employees of the University of Kansas and shall not be employees of LPS.
- b. Assume all responsibility for the employee or employees hired to perform the agreed upon services, including, but not limited to, supervision, compensation, including all employer costs, and required workers compensation and general liability insurance.
- c. Be responsible for its negligent acts or omissions and the negligent acts or omissions of its employees, officers, or directors, to the extent allowed by law.
- d. Maintain logs and/or documentation on the services performed to assist in auditing information.
- e. Consider requests provided by LPS to remove and replace any University of Kansas employee working on this project if LPS documents the need for such change.

2. LPS agrees to:

- a. Pay The KUCR the sum of \$25,000 for qualifying services performed. The payment to KUCR will be paid after USD 497 Board approval. This payment will include all expenses involved in the research and facilitating of CI3T training.
- b. Assume no employment responsibilities for the personnel hired by KUCR to perform the agreed upon services.
- 3. This agreement is effective upon execution by the parties covering the services performed during the period July 1, 2014 through June 30, 2015.
- 4. This agreement may be terminated by either party upon thirty (30) days written notice. In the event this agreement is terminated early, KUCR shall be reimbursed for all non-cancelable obligations incurred prior to the effective date of termination, not to exceed \$25,000 unless additional expenditures ae approved by LPS

Designing Comprehensive, Integrated, Three-Tiered Models (CI3T) of Prevention in Lawrence Public School District's Secondary Schools: Building Multi-tiered Systems Support with an Integrated Focus (LPSD MS HS CI3T Training Project).

Kathleen Lane from University of Kansas will provide professional development and assistance to Lawrence Public Schools (LPS) middle and high schools interested in a comprehensive, integrated, three-tiered (CI3T) model of prevention. The goal is to build schools' capacities to design, implement, and evaluate CI3T models of prevention to (a) prevent the development of learning and behavior problems, and (b) respond more effectively to students with existing learning and behavior problems in inclusive settings.
